

HOW TO SORT WASTE

TYPE OF WASTE	COLOUR OF THE BIN / BAG	WHAT TO THROW?	WHAT NOT TO THROW?
PLASTICS, METAL, MULTI-MATERIAL PACKAGING	yellow	bottle caps, squashed PET drink, cosmetics and household chemicals bottles, plastic bags, plastic films, fruit baskets and delicatessen packaging, plastic food packaging (as well as any plastic products and packaging marked with the recycling symbol), multi-material packaging, e.g. milk and juice cartons, small metal and aluminium packaging (e.g. bottle caps, jar lids, cans, boxes, aluminium foil). Empty and squash bottles and cans. Throw in bottles without bottle caps.	oil bottles and any bottles that are not empty, gums, paint and chemicals canisters, aerosol cans, insecticide cans (and other packages contaminated with hazardous substances), batteries, AGD/RTV, medical plastics, construction foil.
GLASS	green	glass bottles, food jars, glass alcoholic drinks bottles, as well as other glass objects marked with GL70, GL71 and GL72 symbols. Do not throw in broken glass. Emptied glass bottles and jars throw in without lids and corks.	porcelain and ceramics, faience, light bulbs, fluorescent, neon and mercury lamps, reflectors, spectacle lenses, crystal and heat-ptoof glass, TV screens and tubes, mirrors, car and window glass, glass bricks.
PAPER	blue	newspapers, magazines, catalogues brochures, leaflets, flyers, books, notebooks, writing paper, paper shopping bags, cartons, cardboard, corrugated boards, xerographic paper, school and office paper, envelopes, prospectuses. Remove all plastic and metal elements before throwing in paper.	cartons and cardboard covered with aluminium foil (e.g. milk cartons), water-proof packaging paper, greasy and dirty paper, thermal and fax paper, carbon paper, hygienic paper (including diapers), wallpapers, cement bags.
BIODEGRADABLE WASTE	brown	garden waste (grass, leaves, twigs, etc.), rotten flowers and plants. Throw in green waste solely from residential property areas.	liquid food waste, meat, food leftovers, ash, animal faeces.
MIXED WASTE	black	completely extinguished furnace, fireplace or grille ash, personal hygiene products, food leftovers (e.g. sausages, meat and bones), greasy and dirty paper, cooking oil bottles, styrofoam, as well as all waste that cannot be qualified into any of the previous categories.	medicine, chemicals, electronics, ibatteries, construction waste, used car batteries, high-volume waste and other hazardous waste, clothes and other textiles.
